#### THE CHANCELLOR RECOMMENDS:

that the Board authorizes the Chair to execute agreements with Chicago Area Interpreter Referral Services (CAIRS), Deaf Communication by Innovation (DCI), and Lester and Rosalie Anixter Center to provide sign language interpreter services for the period from September 12, 2012 through August 31, 2013, at a total cost not to exceed \$250,000.

#### **ORIGINAL TERM:**

The original term of the agreements shall commence on September 12, 2012 or Board execution and end on August 31, 2013.

#### **RENEWAL TERM:**

Each agreement shall have two (2) options to renew for a one year term.

#### **SCOPE OF SERVICES:**

The firms will provide sign language interpreters for hearing impaired students in the classroom environment and during academic advising sessions on an as needed basis at all seven (7) campuses. The firms will provide services that will supplement the roster of up to 10 part-time sign language interpreters hired by CCC as of the Fall 2012 semester in the event that CCC is unable to meet the demand due to shortage of interpreters or conflicts in scheduling.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

Providing sign language interpreter services is required for City Colleges of Chicago to remain in compliance with the Americans with Disabilities Act (ADA). CCC will hire up to 10 part time sign language interpreters to cover 100% of the hearing impaired students' needs. Ensuring sign language interpreter services are available will assist hearing impaired students during class time to gather notes and needed class information to complete their course requirements and assist them during non-classroom based sessions and events. It is in the best interest of the District to utilize the firms listed above as a backup in the event the demand for sign language interpreter services unpredictably increases, there is a shortage of CCC interpreters or there are scheduling conflicts. It is expected that by hiring part-time sign language interpreters, the District can save up to \$250,000 per year.

#### **VENDOR SELECTION CRITERIA:**

Specifications were prepared by District Procurement staff, publicly advertised on February 13, 2012 in the Chicago Sun Times, and Request For Proposal (RFP) #SH1201 was sent to (6) six firms. A pre-proposal conference was conducted on February 21, 2012, with the five firms who responded to the RFP on March 9, 2012: 1) Deaf Communication by Innovation; 2) Chicago Area Interpreter Services (CAIRS); 3) Lester and Rosalie Anixter; 4) Quintana Interpreter Services, Inc.; and 5) Geneva Worldwide. Geneva Worldwide was deemed non-responsive as it did not submit its proposal in accordance with submittal requirements.

All qualifications were reviewed, evaluated and ranked by staff which included the Disability Access Center Coordinators from Harold Washington, Truman and Olive-Harvey Colleges, the Executive Director of Business Operations from Kennedy King College and Administrative and Procurement Services staff.

#### The evaluation criteria included:

- 1. Responsiveness and quality of proposal
- 2. Qualifications and experience of the Proposer, past performance of the firm(s) on other contracts in terms of size, scope and quality of services and compliance with performance schedules. CCC may solicit reference information from previous clients
- 3. Qualifications and experience of committed personnel
- 4. Specialized experience of the Proposer
- 5. Ability to provide personnel to work closely with seven (7) Disability Access center Directors at respective campuses
- 6. Fees in relation to the Scope of Services
- 7. M/WBE Compliance Plan

Based on the evaluation scoring, staff recommends the acceptance of the proposals from the top three firms: Chicago Area Interpreter Services (CAIRS), Deaf Communication by Innovation (DCI) and Lester and Rosalie Anixter Center to provide City Colleges of Chicago deaf and hard of hearing students with sign language interpreter services on an as needed basis.

#### M/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above request and CAIRS and Lester and Rosalie Anixter Center are in compliance with the Board Approved Participation Plan. DCI is a City of Chicago certified business enterprise for people with disabilities which do not qualify as a certification accepted by City Colleges, and M/WBE Compliance recommends granting DCI a waiver for compliance with the Board Approved Participation Plan.
