that the Board of Trustees authorizes the issuance of a purchase order for the purchase of a 2013 Ford E-350 XLT Extended Cab Wagon for daily operational needs including transportation for production and engineering staff at WYCC PBS Chicago at a total cost not to exceed \$27,067.24.

The purchase will take place between January 10, 2013 and February 7, 2013.

SCOPE OF SERVICES:

Sutton Ford will provide a 2013 Ford E-350 XLT Extended Cab Wagon to WYCC for daily operational needs.

BENEFIT TO CITY COLLEGES OF CHICAGO:

WYCC has determined that there is a need to purchase a new vehicle for its operational needs for Engineers and Production crew. The existing vehicle is quickly approaching obsolescence and requires frequent maintenance and repairs.

VENDOR SELECTION CRITERIA:

The Office of Administrative & Procurement Services in conjunction with WYCC PBS Chicago has determined that it is more cost effective to utilize the above-listed vendor under a joint purchasing agreement with the City of Chicago Vehicle (Fleet Management) contract for the purchase of the Ford E-350 Wagon which will allow City Colleges of Chicago to take advantage of the pricing available to the City of Chicago for all of its vehicle/truck needs. Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District's competitive bidding requirements

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above referenced request for the purchase for a super duty truck available through joint purchasing with the City of Chicago. Sutton

Ford met the goals for participation for the City of Chicago through indirect participation. The Office of M/WBE Contract Compliance recommends a partial waiver of indirect participation of 8.1% MBE and 2.5% WBE to be in compliance with the Board Approved Contract Participation Plan.
