that the Board of Trustees authorizes the Chair to execute agreements with Christy Webber & Company to provide landscape management services at a total cost not to exceed \$1,099,796, and with Speedy Gonzalez Landscaping, Inc. to provide landscape management services, at a total cost not to exceed \$697,000 for the period from June 15, 2013 through June 15, 2015.

#### TERM:

The term of both two year agreements (consisting of five seasons for lawn care each year and four seasons of tree and shrub care each year) will begin in the summer season, June 15, 2013 to October 15, 2013, and will end after the spring season, May 15, 2015 to June 15, 2015.

## **SCOPE OF SERVICES:**

Both firms will provide extensive turf and tree care services including lawn fertilization and integrated pest management (I.P.M.) over a very short time period. Comprehensive and complete tree and shrub fertilization will take place for all sites which also includes the I.P.M. for both, along

with pruning, mulching, and thorough grounds cleanup as per the technical specifications and schedules prepared by City Colleges of Chicago Facilities Planning Division. Certified arborist will also be examining soil and tree conditions to make sure the correct chemistry is being developed for the care and fertilization. Actions are required monthly and seasonally.

## BENEFIT TO CITY COLLEGES OF CHICAGO:

This District wide landscape management program will beautify the campuses and make them more pleasing to students, faculty and staff. This standardized program will also protect CCC's multimillion dollar investment in old and new plant material. Lastly, the program will demonstrate to the local communities the importance of proper grounds maintenance and care of the environment.

## **VENDOR SELECTION CRITERIA:**

On January 24, 2013, Sealed Bid DV1301 was publicly advertised and posted on the City Colleges of Chicago website. Twenty-eight (28) firms were contacted. A pre-submittal conference was held on February 7, 2013 and fourteen (14) firms attended the meeting. On February 21, 2013, three (3) bids were received for Landscape Management Services:

The two firms above were selected as the lowest, most responsive and responsible vendors for the work to be performed at specific campuses. A third firm, KGI Landscaping. Co, submitted a bid, however, they were found to be non-responsive.

The Office of M/WBE Contract Compliance has reviewed the above proposals from Christy Webber & Company and Speedy Gonzalez and determined that both firms are in compliance with the Board Approved Participation Plan.
