**PURCHASE OF 2013 FORD UTILITY POLICE INTERCEPTOR VEHICLES
ROESCH FORD, INC.

THE CHANCELLOR RECOMMENDS:

that the Board of Trustees approves the issuance of a purchase order to Roesch Ford, Inc. for the acquisition of three 2013 Ford Utility Police Interceptor All Wheel Drives for use at Richard J. Daley, Truman and Wilbur Wright Colleges, at a total cost not to exceed \$76,362, plus an additional amount of \$1,000 for license and titles.

TERM:
The vehicles will be purchased prior to June 30, 2013.

SCOPE OF SERVICES:
Roesch Ford, Inc. will provide three 2013 Ford Utility Police Interceptor All Wheel Drive vehicles for use by Richard J. Daley, Harry S. Truman and Wilbur Wright Colleges as needed for the Office of Safety and Security.

BENEFIT TO CITY COLLEGES OF CHICAGO:
Each of the colleges has determined that there is a need to purchase a new Campus Safety and Security Police Vehicle that will be used by the Campus Safety and Security to patrol their facilities. The vehicle for Daley is intended to replace a 1996 high mileage Jeep that is currently in poor mechanical and physical condition for use as a security vehicle. The vehicle for Truman is intended to replace one that has been moved to District office, and the vehicle for Wright is intended to replace a 2003 high mileage Chevrolet Blazer that is currently in poor mechanical and physical condition for use as a security vehicle.

VENDOR SELECTION CRITERIA:
The Office of Administrative & Procurement Services in conjunction with the Office of Safety and Security has determined that it is more cost effective to utilize the above-listed vendor under a joint purchasing agreement with the City of Chicago Vehicle (Fleet Management) contract #26235 for the purchase of three 2013 Ford Utility Police Interceptor All Wheel Drive vehicles. The contract will allow City Colleges of Chicago to take advantage of the pricing available to the City of Chicago for all

of its vehicle/truck needs. Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above request and it is an intergovernmental purchase from the City of Chicago. Roesch Ford has MBE and WBE participation through the City of Chicago and its M/WBE plan. The Office of M/WBE Contract Compliance recommends accepting the City's M/WBE commitment to be in compliance with Board Approved Participation Plan.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
