# MANAGED HOSTING AND SERVICES CEDAR CRESTONE, INC. OFFICE OF INFORMATION TECHNOLOGY DISTRICT OFFICE

#### THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair to execute a professional services agreement with Cedar Crestone (CCI), Inc. to remotely host PeopleSoft applications and related infrastructure for the period from June 1, 2013 or upon Board execution through May 31, 2016, with two one-year options to renew at a total cost not to exceed \$4,500,000 for the contract term.

**VENDOR:** CedarCrestone, Inc. (CCI)

**USER:** District-wide

#### TERM:

The term of the agreement will commence on June 1, 2013 or upon Board execution and end on May 31, 2016, with an option to renew for two (2) additional twelve (12) month periods.

#### **SCOPE OF SERVICES:**

CCI will perform the following tasks:

- Upgrading City Colleges of Chicago's PeopleSoft (PS) and PeopleSoft-related applications to the latest CCI supported platform (including servers, operating system, and databases,)
- Moving CCC's PeopleSoft (PS) and PeopleSoft-related applications to CCI's managed hosting environment
- Coordinating with CCC to ensure access and connectivity to the new manage hosting environments
- Maintaining agreed upon Service Level Agreements (SLAs) with CCC after the initial build-out for the duration of the contract terms

Port-Back Guarantee	If CCI fails to perform to the terms of your contract, CCI will port CCC systems back to the location of your choosing. The port-back costs are paid by CedarCrestone.
System Availability	CCC systems availability will be 99.8% or higher. If lower than 99.5%, then CCC's next month's hosting fee is <i>free</i> .
Security	If a security breach occurs due to failure to follow published procedures and best practices, then CCC's next month's hosting fee is <i>free</i> .
Disaster Recovery	If Production operations are not recovered and restored within 2 hours, then CCC's next month's hosting fee is <i>free</i> .
Performance	CCI will commit to setting system performance goals, then ensure OLTP performance remains within defined benchmark levels throughout the course of the agreement with penalties of 2% for each percentage point below 98%.
Issue Response Time	CCI responds to any issue or trouble ticket in 15 minutes or less. If that does not occur, then CCC receives increasing percentage credits.
Issue Resolution Time	CCI will resolve tickets and issues within 4 hours for high priority Production issues. If that does not occur, then CCC receives increasing percentage credits.

#### **VENDOR SELECTION CRITERIA:**

Pursuant to State law, purchases that are economically procurable from a sole source are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above agreement request and recommends a waiver of the Board Approved Participation Plan because Cedar Crestone is the sole owner and manufacturer of a proprietary managed hosting solution and in turn there are no

certified MBE or WBE subcontracting opportunities.

**GENERAL CONDITIONS:** 

Inspector General - It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the

Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions

of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal

year is subject to appropriation in the subsequent fiscal year.
