that the Board of Trustees authorizes the Chair to exercise the option to renew the agreement with Verio Graphics to provide banner, signage, vehicle wrapping and other large format printing and installation services for the period commencing no sooner than July 10, 2014, and continuing through June 30, 2015, at a total cost not to exceed \$300,000.

ORIGINAL TERM:

Pursuant to Board Report #32125 approved on December 12, 2013, the original term of the agreement commenced on December 12, 2013 and ended on June 30, 2014.

RENEWAL TERM:

The renewal term of the agreement shall commence no sooner than July 10, 2014 and end on June 30, 2015.

SCOPE OF SERVICES:

The scope of services to be delivered will be large format printing and installation, including vehicle wrapping, outdoor billboard signage and window wraps.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Institutional Advancement has reviewed this request for service and has determined that it would be in the best interest of the District to continue to work with Verio Graphics to provide large format graphics and signage to help build public awareness of City Colleges of Chicago (CCC), and its programs and to support student recruitment activities.

VENDOR SELECTION CRITERIA:

The contract being utilized is part of the joint purchasing agreement that has been advertised and awarded in accordance with the procurement procedures of the Chicago Park District, a sister agency to CCC, under specification #P-10004, dated February 23, 2011, respectively for Banners, Signage & Large Format Printing Services. Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of Contract Compliance has reviewed the above referenced renewal and recommends a 2% WBE waiver of the Board Approved Participation Plan. It is also recommended that the Chicago Park District's M/WBE Participation Plan be accepted as the agreement is the result of a joint purchase arrangement with the sister agency.
