that the Board of Trustees authorizes the issuance of a purchase order to Anatomage for the purchase of a Virtual Anatomy Dissection Table for use by the Departments of Health Sciences and Instruction at Malcolm X College at a total cost not to exceed \$82,000.

The term of this purchase shall commence no sooner than June 5, 2014 until delivered and accepted.

SCOPE OF SERVICES:

Anatomage will provide the Health Science and Instruction Departments of Malcolm X College a Anatomage Virtual Anatomy Dissection Table for instructional purposes.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Anatomage Virtual Dissection Table will provide the City Colleges of Chicago, College of Health Sciences with modern technology to support the education of students in various health science and pre-health science disciplines. The Anatomage Virtual Dissection table has several benefits over traditional anatomical specimens including the ability to have virtually unlimited use by faculty for instruction, no replacement costs as with traditional cadaver based anatomy labs and less maintenance and disposal costs compared to housing and maintaining cadavers on site within the college. Procurement of this virtual dissection table will allow more student users per academic year as the anatomical specimen presented is reusable for various classes across disciplines. The Anatomage Virtual Dissection Table also uniquely allows uploading of clinical data (X-rays, MRI's, MRA's and CT-Scans) for visualization in a 3-Dimensional format for instructional use.

VENDOR SELECTION CRITERIA:

As the Anatomage Virtual dissection table is the only 3-D virtual dissection table available commercially for instructional purposes and the product is only available from Anatomage, the college has selected this vendor after reviewing other software products with less functionality. Pursuant to state law, goods or services which are economically procurable from only one source

are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above purchase request and recommends a waiver of the Board Approved Participation Plan due to the nature of the purchase ("Virtual Anatomy Dissection Table") and the absence of subcontracting opportunities.

GENERAL CONDITIONS:
