THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the issuance of a purchase order to Covidien for the purchase of two Puritan Bennett 840 Ventilators for the Health Science Department at Malcolm X College at a total cost not to exceed \$41,000.

TERM:

The term of the purchase shall commence on March 6, 2014 until delivered and accepted.

SCOPE OF SERVICES:

Covidien will provide the Respiratory Department of Malcolm X College with two Puritan Bennett (PB) 840 Ventilators for instructional purposes.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The PB 840 ventilator is the most commonly used industry standard in the Chicago land area. This ventilator will require the least amount of orientation of our students at their practical clinical sites. The ventilator software is able to allow the ventilator to be used for all populations of patients including premature neonates, pediatric and adult patients. The ventilator has all the monitoring software and trending that will allow us to identify changes in the patient's condition and determine the ability to best manage the patient as his or her condition improves or requires greater and more sophisticated modes of ventilator support and response. The PB 840 provides all of the standard modes for maintenance, weaning and support of patients with severe decreases in compliance and in need of pressure control ventilation and tube compensation for those with end stage disease such as chronic obstructive pulmonary disease.

VENDOR SELECTION CRITERIA:

Pursuant to state law, goods or services which are economically procurable from only one source are exempt from the District's competitive bidding requirements. Three informal bids were solicited from Covidien, Maquet Medical Systems, USA and Hamilton Medical, Inc. The bids received from Maquet Medical Systems, USA and Hamilton Medical, Inc. did not meet the clinical training needs and provide the same functionality and software capabilities as the Puritan Bennett 840 Ventilator.

MBE/WBE COMPLIANCE:

The Office of M/WBE Contract Compliance has reviewed the above referenced purchase request and recommends a waiver of the Board Approved Participation Plan because there are no direct subcontracting opportunities available for the sole source provider that is located out of state.

GENERAL CONDITIONS:

Inspector General – It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.6.4 (b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community Act all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
