TERM:

The term of the agreement shall commence no sooner than November 10, 2014 and will continue until the later of the date of completion of the construction projects or March 1, 2015.

SCOPE OF SERVICES:

Boelter Contract and Design shall furnish and install cafeteria cooking equipment i.e. convection ovens, sandwich ovens, reach-in refrigerators, etc. as detailed in their quotes (dated 10/10/14) for cafeterias at Olive-Harvey and Daley Colleges and the Incubator Kitchen at Kennedy-King College.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Administrative Services and Procurement Services has reviewed this request for services and has determined that it would be in the best interest of the District to purchase the equipment directly without a markup to be added if it were included in the JOC renovation. With

new cooking equipment the colleges will be better able to meet today's student tastes and nutritional needs.

VENDOR SELECTION CRITERIA:

Pursuant to Board Report 29816, the Board approved the use of US Communities Governmental Purchasing Alliance purchasing consortium. Boelter Contract and Design is a direct distributor for Premier-US Foods Services, the consortium vendor.
