THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair to execute an agreement with Garland/DBS, Inc. for the provision and installation of roofing materials at the Truman College Phase II Building for the period commencing no sooner than December 10, 2015 through December 31, 2017, at a total cost not to exceed \$750,535, which includes an 8% unforeseen conditions contingency.

USER: Truman College

TERM:

The term of the agreement shall commence no sooner than December 10, 2015 and continue through December 31, 2017.

SCOPE OF SERVICES:

Garland/DBS, Inc. will remove areas of roofing deemed to be wet through the insulation as per the infrared scan, reinstall insulation, patch areas, remove top coating of roofing and replace with new Garland Roofing material as per the scope of services issued to certified roofing companies. Due to the nature of roofing work, the Office of Administrative Services is recommending approval of an 8% unforeseen conditions contingency on this project.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Garland/DBS and was selected through to perform roofing analysis to study our roofing system. As a supplier of materials, it was deemed that they could perform the required work. Using Garland/DBS, Inc. for this work is a proactive measure to minimize any risk associated with roof leaks over the student facing areas in the Phase II Building which include the gym, theater, cosmetology, and fitness center. Left untended, this could lead to costly internal damage to the areas mentioned as the roof is near the end of its useful life.

VENDOR SELECTION CRITERIA:

Pursuant to Board Report #29816 and #32583, the Board approved the use of US Communities Government Purchasing Alliance to maximize volume discounts on various products and services. Garland/DBS, Inc. was competitively awarded Contract 14-5903 to offer turnkey roofing solutions to members.

Garland/ DBS, Inc. was selected through a competitive bid process administered through the Office of Procurement for Cobb County in Marietta, Georgia. One responsive bid was received by Garland/DBS, Inc. Pursuant to state law, contracts for goods or services procured from another governmental agency are exempt from the District's competitive bidding requirements.

To ensure there was a fair competitive price to the District, Garland was required to solicit three bids from local roofing companies certified to install its roofing system. Bids were received from the following contractors:

Garland/DBS, Inc. has agreed to utilize the lowest responsive bid from CIC Corporation which meets our needs to complete the project.
