THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair to execute an agreement with Netech to provide Network Equipment, Installation and Support Services that will support the New Malcolm X College Campus and its integration into City Colleges of Chicago's District-wide network for the period commencing no sooner than July 13, 2015 through January 31, 2018 at a total cost not to exceed \$3,432,475.

TERM:

The term of this agreement shall commence no sooner than July 13, 2015 and will continue through January 31, 2018.

SCOPE OF SERVICES:

The Malcolm X College (MXC) and School of Health Sciences is the designated healthcare hub for City Colleges of Chicago, and is at the forefront of meeting the growing need for healthcare professionals. Throughout the New MXC complex, new technology equipment and capability will be installed including new high speed ethernet, wireless networks, and upgraded personal computers (PCs). The Network Services agreement will establish the backbone for connectivity on the MXC Campus and to the existing district-wide network to support all faculty and staff network devices and student owner devices to support pedagogical activities.

The agreement is the result of a competitive sealed bid process on May 13, 2015 that sought the procurement of owner negotiated Network Equipment and the services to configure, install, test and support the transition to the new MXC Network and its interoperability to all required network technologies at MXC.

The bid response was for the procurement of all Network Equipment with a 3 year warranty (equipment includes all switches, firewall, patch cables and other network equipment) and the Network Services to build, integrate test and activate the IT network for the New MXC College campus.

BENEFIT TO CITY COLLEGES OF CHICAGO:

This technology ensures that students at the New MXC and School of Health Sciences at the City Colleges of Chicago are provided with access to state-of-the-art facilities, student, staff and conference center IT and network capabilities that support the complex.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff and Sealed Bid# TF1504 was publicly advertised on May 13, 2015. Twenty (20) companies were contacted and a pre-proposal conference was held on May 20, 2015. Three (3) firms responded to the Bid on May 28, 2015: 1) World Wide Technologies, 2) PACE and 3) Netech.

All proposals were reviewed, evaluated, and ranked by staff which included OIT, Administrative and Procurement Services and MBE/WBE Contract Compliance.
