THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair to execute an agreement with Whitlock to provide state-of-the-art Audiovisual (AV) equipment and installation services for the New Malcolm X College and School of Health Sciences for the period commencing no sooner than June 1, 2015 through June 30, 2017, at a total cost not to exceed \$8,529,780.

TERM:

The term of this purchase shall commence no sooner than June 1, 2015 and will continue through June 30, 2017.

SCOPE OF SERVICES:

The New Malcolm X College (MXC) and School of Health Sciences is the designated healthcare hub for City Colleges of Chicago, and is at the forefront of meeting the growing need for healthcare professionals. AV capabilities will be available throughout the New MXC as follows:

The New MXC classrooms will have presentation capability with wired and wireless displays sources. A touchscreen display will be integrated into a lectern for annotation with on all sources. Active Learning Classrooms will have presentation capability on multiple displays with multiple wired and wireless displays sources, along with an installed OFE computer. A touchscreen display will be integrated into a lectern for annotation with on all sources.

 Laboratories will have presentation capability with wired and wireless displays sources, along with an installed OFE computer. A touchscreen display will be integrated into a lectern for annotation with on all sources.

- Breakout rooms will have similar functionality as Enhanced Classrooms. Competition Gymnasium will have audio and video presentation capability.
- Student areas such as enclave rooms will have presentation capability with wired and
 wireless display sources, along with an installed OFE computer. Group Study rooms will
 have presentation capability with wired and wireless display sources. Study Areas will
 have presentation capability with wired display source.
- Conference Rooms will have presentation capability with wired and wireless displays sources, along with an installed OFE computer and USB camera. A table mounted button panel will control the display and select active source.
- Auditorium (or Lecture Hall) and the three-section Conference Hall will have similar functionality as Enhanced Classrooms with additional sources and cameras, along with greater sound control and camera management. Full hardware based video conferencing will be allow be provided for these spaces.

The project deliverables include but are not limited to:

- 1. AV equipment and Owner Furnished Equipment (OFE) installation and labor, to create a fully functional system (per drawing and diagram) for the building
- 2. One year warranty on products and installation
- 3. Four preventive maintenance visits to make adjustment to video equipment and replace disposables (projector lamps)
- 4. AV assistance and training materials during owner training

The scope of the sealed bid included but is not limited to:

- 1. Equipment and installation labor, including installation of Owner Furnished Equipment (OFE) as noted on the drawings, for a fully functional system
- 2. Miscellaneous components, hardware, interconnections and terminations required for proper operation of all systems
- 3. All components or systems shown on the drawings, referenced in these specifications, or both
- 4. Verification of accuracy and completeness of equipment lists, dimensions, mounting details, and equipment compatibility
- 5. Accurate documentation of the equipment and installation
- 6. Warranty on equipment (3 years) and services (1 year)
- 7. Test equipment, tools, ladders, lifts and scaffolding required for installation
- 8. Daily and final cleanup of debris caused by installation
- 9. Assistance during owner AV training

BENEFIT TO CITY COLLEGES OF CHICAGO:

This technology ensures that students at the New MXC and School of Health Sciences at the City Colleges of Chicago are provided with access to state-of-the-art facilities and instructional support AV capabilities that support quality teaching and learning.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff. Sealed Bid# TF1409 was publicly advertised on March 23, 2015. Nineteen (19) companies were contacted. Four (4) firms

responded to the Bid on April 7, 2015: 1) Whitlock, 2) Integrisys/Rex, 3) Conference Technologies and 4) AVI-SPL.

All proposals were reviewed, evaluated, and ranked by staff which included the consultant Waveguide, OIT, Administrative and Procurement Services and MBE/WBE Contract Compliance.
