#### THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair to execute an agreement with Axiom Consulting Partners, LLC to provide consulting services for Performance Management design, deliverables and implementation commencing no sooner than October 1, 2015 through June 30, 2017, at a total cost not to exceed \$460,000.

#### TERM:

The term of the agreement shall commence no sooner than October 1, 2015 and will continue through June 30, 2017.

#### **SCOPE OF SERVICES:**

Axiom Consulting Partners, LLC will design and implement a performance management system for City Colleges of Chicago. The performance management system will address: 1) the selection of the most appropriate competencies and performance metrics/goals for each role/individual; 2) the development, implementation and effective utilization, training and tools for evaluating and communicating performance, and building the capability amongst managers; 3) approaches for ensuring a consistent culture of accountability; and 4) systemic approaches for leveraging talent and developing a pipeline of future leaders.

The scope of these consulting services is the first module of an overall performance management system strategy to create a seamless integration to an online platform.

#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The benefits of a successful performance management system will be the achievement of greater business outcomes in terms of meeting CCC's overall goals and objectives connected to greater student success. We intend for this performance management system to enhance our culture of accountability through feedback, conversation and documentation via performance management tools and on-line administration. The resulting talent management program will be integrated into a technology solution once the design and tools of a performance management program has been implemented and accepted.

#### **VENDOR SELECTION CRITERIA:**

Specifications were prepared by District Procurement staff and a Request for Proposals was publicly advertised on June 19, 2015. Sixteen (16) companies were contacted and a preproposal conference was held on July 1, 2015. Five (5) firms responded to the Bid on July 14, 2015. They were Axiom Consulting Partners, LLC, Towers Watson Delaware Inc., Mercer (US) Inc., Deloitte Consulting LLP and Halogen Software Inc.

All proposals were reviewed, evaluated, and ranked by staff which included Human Resources and Staff Development, Office of Information Technology, Administrative and Procurement Services and MBE/WBE Contract Compliance based on the evaluation criteria from the RFP listed below:

- 1. Quality of Response and Technical Approach
- 2. Staffing Qualifications and Experience
- 3. Implementation Plan and schedule
- 4. Cost/Fees
- 5. M/WBE goals

Three finalists, Axiom Consulting Partners, LLC, Towers Watson Delaware Inc. and Mercer (US), Inc. were invited to present oral presentations on August 11, 2015.

Based on the overall scoring, the Evaluation Committee recommends the acceptance of the responses, technical approach, staff qualifications, implementation plan and lowest fee offered in the proposal from Axiom Consulting Partners, LLC would best meet the Performance Management Consulting needs of the CCC sites.

#### MBE/WBE COMPLIANCE:

The Office of MBE/WBE Compliance has reviewed the proposed agreement and recommends a partial MBE waiver of the Board Approved Participation Plan. The vendor has committed to the following:
