# I. CALL TO ORDER REGULAR BOARD MEETING

Chair Middleton called to order the December 1, 2016 Regular Board Meeting at 9:03 a.m.

## II. ROLL CALL

## III. REMARKS FROM CHAIR MIDDLETON

Chair Middleton with an update on the leadership searches currently underway at City Colleges of Chicago. The Chair noted that the Chancellor Search Committee would be conducting its initial review of applications for the position of Chancellor this month. based on that review, the candidate will identify a short list of semi-finalists and plan next steps in its process. The position announcement for the Provost/Chief Academic officer job was released on November 14<sup>th</sup> and the pool of candidates for that position is being developed at this time. Chair Middleton noted that by the February meeting of the board, the board intends to update the board bylaws to update the duties and responsibilities of the Provost/Chief Academic Officer.

Next, Chair Middleton noted the recent accomplishments of Wright College English Professor Daniel Borzutzky, who in November, won the 2016 National Book Award for Poetry. His book, "A Performance of Being Human," has been chosen as the finest work of poetry in the United States in the year 2016.

#### IV. STUDENT TRUSTEE'S REPORT

Student Trustee Buitron began by noting her role as an advocate for all students at City Colleges of Chicago. She also noted her participation in the ICCB Student Advisory Council. As a student leader, she meets regularly with SGA presidents from all seven City Colleges and they work collaboratively to address district-wide concerns. She noted that the College Presidents meet regularly with representatives of their respective SGA's and appreciate the opportunity to engage on a variety of topics. Student Trustee Buitron noted that as a group the SGA leadership has meet districtwide to plan a plate form for advocacy on MAP funding statewide and to support BSF programs within community colleges. She further noted the Wake up with SGA program at Harold Washington College, the Safe Space campaign at Wright College and the work at Kennedy-King college to provide support to students during finals.

In response to Student Trustee Buitron's report, the Chair noted that he ran into many of the SGA leadership while attending the ICCTA conference in Naperville in November and that they had a good, unplanned conversation.

## V. <u>CHANCELLOR'S UPDATES</u>

Chancellor Hyman welcomed those in attendance and noted the board would be considering a Welcoming Campus resolution at today's meeting and that the board will be considering resolution 1.02, which will authorize the transfer of funds from the working cash fund to the education fund due to a lack of State funding. Chancellor Hyman noted that the State has appropriated only 37 percent of expected funding to City Colleges over the past two fiscal years and have made significant cuts in the MAP grant program, resulting enrollments by MAP-eligible students falling 30 percent below fall 2014 levels. She noted that while the District has weathered these challenges, doing so has meant slowing down hiring, cancelling capital investments and reducing overall expenses. These adjustments have only been possible with dedicated engagement and sacrifice by the College Presidents and the Vice Chancellors, however there is a huge strain on the system and our ability to continue to fuel our academic programs and operations at the levels we have become accustomed to is in jeopardy.

#### VI. <u>DISTRICT UPDATES</u>

The December district update was on the art programs at Harold Washington College. A copy of the presentation by Harold Washington College President Margaret Martyn, Professor Jess Bader and HW students Jerico Walls and Theresa Johnston can be found <a href="here">here</a>.

At the end of the presentation, Secretary Duque commented the student presenters for their hard work and noted that the national focus on STEM fields (Science, Technology Engineering and Math) are now being referred to as STEAM fields (now also recognizing artistic endeavors) as critical and valuable fields of study. Secretary Duque encouraged the students to simultaneously embrace the artistic and entrepreneurial sides of their personas as they proceed in their education at City Colleges and beyond.

Chair Middleton noted that the quality and scope of programing available at City Colleges of Chicago, including the arts is extremely important and valuable given the importance of arts to the centrality of the human condition and human existence.

## VII. PUBLIC PARTICIPATION

There were two (2) public participants.

- 1) Mr. Scott spoke about increased awareness and enrollment at Malcolm X College, the enrollment of CHA residents and his artistic critique of the Malcolm X facility.
- 2) Professor Tony Johnston, President CCCTU, Local 1600, spoke about the importance of sanctuary campus and safe spaces for immigrant students.

Resolution 1.05 reinforces the District's long-standing commitment to maintaining a safe space and a welcoming environment for all of our students, our faculty, our staff, and for other people who come to our institutions. It further endorses the strong steps taken by the City of Chicago and Mayor Emanuel's administration with the City Council in passing the Welcoming City Ordinance, and re-affirms that acts of discrimination and harassment based on immigration status, among many other protected statuses, of a potential or current member of the staff or student body would be a violation of the policies and procedures of the Board. The Chair noted with gratitude the work and engagement on this issue by Chancellor Hyman and Executive Vice Chancellor Pernot.

Secretary Duque noted that the Board of the City Colleges of Chicago represents one of the most diverse communities of students, faculty, administration in the country and she was pleased and encouraged by this resolution which affirms our intent to be a welcoming and opening institution and space for all.

Student Trustee Buitron expressed her gratitude to the Board and the administration for taking this step and for supporting the love of education that our students have, regardless of their background.
