RESOLUTION

**AUTHORIZING THE EXTENSION OF AN AGREEMENT BETWEEN THE BOARD OF TRUSTEES OF
COMMUNITY COLLEGE DISTRICT NO. 508 ON BEHALF OF RICHARD J. DALEY COLLEGE AND THE
ELECTRICAL JOINT APPRENTICESHIP TRAINING TRUST**

WHEREAS, the Illinois Public Community College Act, as amended, lists the powers and duties of community college districts in the State of Illinois, and states in 110 ILCS 805/3-30, that:

The board of any community college district has the powers ... that may be requisite or proper for the maintenance, operation and development of any college or colleges under the jurisdiction of the board.

WHEREAS, Richard J. Daley College, in conjunction with the Electrical Joint Apprenticeship Training Trust (“Trust”), has negotiated an extension of an Agreement beginning January 2, 2018 to continue to offer an Associate in Applied Science Degree Program in Electrical Construction Technology and Communication Technology along with two basic certificates and two advanced certificates;

WHEREAS, the Trust will continue to provide, at its expense, individuals qualified to teach the Technical Education courses and to provide all other instructional needs required in connection with the Program; and

WHEREAS, the Trust agrees to provide, at its expense, the equipment, materials, property, supplies and tools. Further, the Trust, at its own expense, is responsible for the maintenance and care of all its equipment and property of the Program; and

WHEREAS, during the term the Board agrees to waive all tuition and fees (except tuition and fees for General Education courses not offered by the Trust and taught by Daley College instructors); and

WHEREAS, that the Board agrees to provide, at its expense, certain space at its Arturo Velasquez Technical Institute until January 2, 2028 unless otherwise terminated by the Board and the Trust; and

WHEREAS, the Board and the Trust have revised the Program to align with the expectations for apprenticeship programs in Illinois in compliance with the Implementation of Apprenticeship Programs Policy approved by the Illinois Community College Board on January 27, 2017;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees authorizes the Chairman to execute an extension of the Agreement with Daley College and the Electrical Joint Apprenticeship Training Trust as recited herein.
