THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair to execute a renewal agreement with Heritage Environmental Services to provide chemical and biological disposal services for a total cost not to exceed \$38,475.

ORIGINAL TERM:

The term of the agreement will commence on March 3, 2016 and end on March 2, 2017.

RENEWAL TERM:

The renewal term of the agreement shall commence in March 9, 2017 and continue through March 8, 2018.

SCOPE OF SERVICES:

Heritage will provide full service chemical and biological waste removal, transportation and disposal including: ongoing and emergency chemical and biological waste containers, removal, transportation and disposal services including all transportation and disposal documentation and training on best practice.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Administrative Services and Procurement Services has reviewed this request for services and has determined that it would be in the best interest of the District to move forward with Heritage Environmental Services as the chemical and biological waste disposal service for the District.

VENDOR SELECTION CRITERIA:

Specifications were prepared by District Procurement staff and rebid as Sealed Bid #SL1506 Collection & Disposal of Hazardous Chemicals – District-Wide. The bid was publicly advertised on Friday, November 13, 2015. There were nine (9) firms notified for the solicitation. Two firms responded to the Sealed Bid on Thursday, December 3, 2015: 1) Heritage Environmental Services; and 2) Wilpen Environmental Services, Inc. The bid was reviewed, tabulated and evaluated by the Administrative and Procurement Services.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
