# DATA COMMUNICATION AND INTERNET SERVICES AT&T CORPORATION WILBUR WRIGHT COLLEGE

#### THE CHANCELLOR RECOMMENDS:

that the Board authorizes the Chair to execute an agreement with AT&T Corporation to provide data communication and internet services for Wilbur Wright College for the period from April 1, 2017 through March 31, 2019, at a total cost no to exceed \$46,008.

**VENDOR:** AT&T Corporation

**USER:** Cyber Security Program – Wilbur Wright College

#### **ORIGINAL TERM:**

The term of this agreement will commence on April 1, 2017 and end on March 31, 2019.

### **SCOPE OF SERVICES:**

AT&T Corporation (AT&T) will provide dedicated internet service of up to 250 Mbps, giving us the ability to send and receive program content to the cyber security classroom as needed. An agreement has been negotiated for service for a period of two years beginning April 1, 2017 through March 31, 2019 at a monthly charge of \$1,917.00 and \$46,008 for a 24-month contract.

#### **BENEFIT TO CITY COLLEGES:**

AT&T will provide dedicated internet services up to 250 Mbps providing the cyber security program the required internet access to successfully teach and train students.

### **VENDOR SELECTION CRITERIA:**

Pursuant to State Law, the purchase of telecommunication services and equipment is exempt from the District's competitive bidding requirements.

## MBE/WBE COMPLIANCE:

The Office of MBE/WBE Compliance has reviewed the above referenced agreement and has determined that due to the nature of the work (internet services) there are no subcontracting opportunities and therefore recommends a waiver of the Board Approved Participation Plan.

#### **GENERAL CONDITIONS:**

Inspector General- It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics- It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability- Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
