RESOLUTION

**TO ENTER INTO AN EASEMENT AGREEMENT WITH CHICAGO DEPARTMENT OF
TRANSPORTATION (CDOT) TO UTILIZE THE DIVVY BIKESHARING PROGRAM TO
LOCATE BIKE SHARING STATIONS ON CAMPUS GROUNDS
OFFICE OF ADMINISTRATIVE AND PROCUREMENT
SERVICES
DISTRICT WIDE**

WHEREAS, the Chicago Department of Transportation utilizes the Chicago Divvy Bike sharing Program to offer transportation options and promote sustainable practices throughout the City of Chicago.

WHEREAS, the City has entered into an agreement (the “Bicycle Sharing Agreement”) with Motivate International, Inc., an Oregon corporation (the “Bicycle Sharing Provider”), a copy of which has been made available to the City Colleges of Chicago, for the Bicycle Sharing Provider to install, operate and maintain the equipment necessary for the System (the installation, operation and maintenance of the equipment, displaying advertising on, repairing, replacing, dismantling and removing the Bicycle Station(s) necessary for the System by the Bicycle Sharing Provider pursuant to the Bicycle Sharing Agreement shall be known herein as the “Project”); and

WHEREAS, City Colleges of Chicago students and employees are eligible for discounts on the annual rate of Divvy Bike Sharing membership;

WHEREAS, Divvy Bike Sharing is a public transportation network that helps City Colleges of Chicago students get from home to classes, internships and jobs;

WHEREAS, City Colleges of Chicago are well served by the current Divvy Bike Sharing implementation area, and our Colleges can serve as future neighborhood expansion sites;

WHEREAS, the Project shall require that the Bicycle Sharing Provider install, operate and maintain certain necessary equipment (bicycles and related equipment known as a “Bicycle Station”) on and at specific locations on and at property owned (or otherwise legally controlled) by the City Colleges of Chicago

WHEREAS, the Project shall therefore require that City Colleges of Chicago grant (or cause to be granted to): (1) the City and the Bicycle Sharing Provider and its contractor(s) and subcontractors (the Bicycle Sharing Provider, its contractors and subcontractors shall be known collectively as the “Contractors”), and the Advertising Provider appropriate rights of entry and access to the Bicycle Station Location(s) on City Colleges of Chicago property for purposes of installing, operating, maintaining, displaying advertising on, repairing, replacing, dismantling and removing the Bicycle Station; and (2) members of the public appropriate rights of entry and access to the Bicycle Station Location for purposes of using the Bicycle Station and the System;

WHEREAS, The Terms of any Easement Agreement shall commence after today’s date and shall expire upon the termination of the Bicycle Sharing Agreement according to its terms.

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois hereby authorizes the Chair to enter into an Intergovernmental Agreement with the Chicago Department of Transportation to utilize the Chicago Divvy Bike sharing Program to locate bike sharing stations on City Colleges of Chicago campus grounds on a case-by-case basis at the discretion of City Colleges of Chicago Vice Chancellor of Administrative and Procurement Services.
