**RESOLUTION  
TO SET TUITION FOR BOARD PROGRAMS  
OFFICE OF FINANCE  
DISTRICT WIDE**

**WHEREAS**, the Illinois Public Community College Act (110 ILCS 805/3-45) authorizes a Community College Board to require tuition; and

**WHEREAS**, Section 4.3 of the Board Bylaws of City Colleges of Chicago provides for the adoption of policies and states that:

“The Board may adopt, from time to time, policy statements, guidelines, procedures, regulations, collective bargaining agreements, codes of conduct, or similar documents issued for the governance of the Board, the District and the Colleges.”

**WHEREAS**, the Chancellor has done a great deal of listening to students, faculty and staff over the last eight months concerning the current tuition structure. In hearing concerns, he created a committee to review the structure and make recommended changes. Based on review and feedback the committee has recommended the changes below beginning with the Summer 2018 term. The committee will continue to meet and may make additional recommendations in the future to ensure continued transparency, equity, competitiveness of tuition and to ensure a sufficient level of tuition revenue; and

**WHEREAS**, the Board of Trustees has previously approved, adopted and now seeks to amend such tuition and fees; and

**WHEREAS**, tuition for credit classes will be charged at a constant credit hour per the chart below, up to a maximum of 12 credits per semester. Students may enroll in more than 12 credits per semester at no additional charge. Pre-Credit classes shall continue to be calculated at one half the rate of full credit classes:

**WHEREAS**, these changes shall apply to all credit and pre-credit enrollment, except for specialized programs including Advanced Certificate Practical Nursing, Associate Degree of Nursing, L’Art de la Pâtisserie, L’Art du Gâteau, Gas Utility and Overhead Electrical, which are unchanged by this resolution.

**NOW, THEREFORE BE IT RESOLVED**, that the aforementioned revisions to tuition shall be adopted by the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois as of April 5, 2018 and effective beginning with the Summer 2018 term.
