The Human Services/CDA Department at Harold Washington and Truman provide support services to the Chicago Department of Family and Support Services to ensure that Early Head Start program staff and CCC students meet the employment and professional development requirements for their positions as defined in the Head Start Re-Authorization Act Performance Standards.

Students with unforeseen urgent financial hardships would be able to apply for up to \$500 in emergency situations, with funds being disbursed directly to the third-party vendor that will provide the service to resolve the emergency.

The Emergency Aid program will be administered by the campus Wellness Centers, with each center receiving up to \$12,000.

Summary

This is a new grant for Wright College. Wright College is proposing a two-year initiative to enhance offerings in Latino/a Studies and to bolster our newly-formed Latin American and Latino/a Studies Program. The project would integrate academic studies with community organizations, fusing the humanities with social and civic engagement in order to order to cultivate active citizenship and community leadership amongst our students. The grant will initially serve approximately 500 students. Funds received from this grant would be used to pay stipends to visiting scholars who will host professional development seminars on teaching Latino/a Studies, course release for the grant's two lead program directors and travel to Washington D.C.

In partnership with the City of Chicago Department of Innovation and Technology, this is a full-time, five-month, intensive boot camp education located at Wright College. The curriculum will prepare 32 students to sit for the Offensive Security Certified Professional certification test which is a hands-on computer/internet penetration testing and ethical computer/internet hacking certification, requiring holders to successfully attack and penetrate various live machines in a safe lab environment.

Summary

The Head Start Support Services Grant is a continuation grant. The City Colleges of Chicago (CCC) has partnered with the Chicago Department of Family Support Services (DFSS) for over 25 years. Each grant cycle, DFFS awards Head Start staff and CCC students with scholarships to enroll in courses taught at the City Colleges of Chicago. We anticipate working with 60 Head Start Staff and CCC students.

The Human Services/CDA Department would provide support services to the Chicago Department of Family and Support Services to ensure that Head Start program staff and CCC students meet the employment and professional development requirements for their positions as defined in the Head Start Re-Authorization Act.

Our goals are to (1) increase the number of qualified teaching and family support staff in the City of Chicago Head Start Programs and (2) increase the number of college students earning a credential of economic value in child development and social work and (3) provide training to assist Head Start staff in earning 15 credit hours of required training per year.

Teaching staff are approved to earn a (A) CDA credential/national Early Childhood Credential (B) Gateways Credential/state-based Early Childhood Credential or (C) an Advance certificate /AAS degree in child development. Family support staff are approved to earn an Advance certificate/AAS degree in Social work. All staff will be offered to opportunity to participate in job related training session(s). The funds from the grant would be used to administer the program through CCC's Human Services Child Development Associate (CDA)

Summary

This is a new grant opportunity for City College of Chicago and aims to fund an 18-month initiative called Post-Secondary Navigator, a partnership with City Colleges of Chicago and Chicago Public Schools (CPS). To encourage post-secondary planning and success beyond high school, CCC will deploy 14 Post-Secondary Navigators who will meet one-on-one with high school juniors and seniors to assist them with accessing college and career planning. Over the course of the initiative, CCC will have a direct impact and ensure the success of roughly 4,000 students through seven CPS Networks and 21 CPS high schools. Funds received from this grant would be used to support salaries, benefits, travel and supplies.

Summary

This is a new five-year grant request that would support two new initiatives at Kennedy-King:

1) Kennedy-King Rising – Funds will be used to upgrade essential equipment, strengthen community relations, and increase industry partner support for three KKC signature programs: automotive and collision technology, culinary arts, and the construction trades. This support will create the path to increase enrollment and double graduation. It is expected that these enhancements will impact nearly 2,500 students from Englewood and other Chicago communities.

2) Cyber-Security and App Development Boot camp – Funds will be used to invest in critical technology, equipment, and facility upgrades that will increase Kennedy-King's capacity to attract diverse talent, and prepare/place students in the high-demand technology jobs throughout the city. It is expected that 200 new trained technologists will participate in this program.
