that the Board of Trustees authorizes the Chair to execute an agreement, upon final approval of the General Counsel of the legal form of such agreements, with Clarity Partners, LLC, to provide an information security assessment including, but not limited to, audit or evaluation of people, process, and technology components which contribute to the delivery of information security services, for a period commencing no sooner than June 7, 2018 through June 30, 2019 at a total cost not to exceed \$150,000.

TERM:

The term of the agreement will commence no sooner than June 7, 2018 and will end on June 30, 2019.

SCOPE OF SERVICES:

Clarity Partners, LLC will provide an assessment, audit, and attestation services and agreed upon procedures in accordance with standard requirements and frameworks such as but not limited to NIST800-53, ISO 27001, COBIT, PCI-DSS, HIPAA-HITECH, FERPA, and CJIS. The assessment will include evaluation of people, process, and technology components which contribute to the delivery of information security services under review. A report will be provided using the NIST Cybersecurity Framework 1.1 format.

BENEFIT TO CITY COLLEGES OF CHICAGO:

This assessment will provide the City Colleges of Chicago with an independent, accurate view of its state of maturity in the Information Security and identify any vulnerabilities that need to be addressed.

VENDOR SELECTION CRITERIA:

The contract is being utilized is part of the joint purchasing agreement that has been advertised and awarded in accordance with the procurement procedures of the City of Chicago through Contract (PO) Number 32560, Specification Number: 121573 awarded 8/31/2015. Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District's competitive bidding requirements.
