**THE CHANCELLOR RECOMMENDS:**

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreements, to execute a renewal agreement with Blue Cross Blue Shield of Illinois (“BCBS”) to provide claims administration services for the District’s self-insured Group Dental Plan for eligible full-time active and retired employees for the period commencing January 1, 2020 through December 31, 2020, at a total cost not to exceed \$120,000.

**VENDOR:** Blue Cross Blue Shield of Illinois

**USER:** All Eligible Employees, Retirees, and their dependents

**TERM:**

The term of this agreement shall commence on January 1, 2019 and ending on December 31, 2019 with three (3) options to renew for one (1) year each.

**FIRST RENEWAL TERM:**

The first renewal term shall commence on January 1, 2020 and end on December 31, 2020 with two (2) remaining options to renew for one (1) year each.

**SCOPE OF SERVICES:**

BCBS provides self-insured dental claims administration services for eligible active and retired employees of the City Colleges of Chicago.

**BENEFIT TO CITY COLLEGES OF CHICAGO:**

It is advantageous to the district to leverage the joint purchasing agreement with Chicago Public Schools (CPS). CPS current agreement consolidated the healthcare and medical provider pool thus providing cost savings on the administrative fees while maintaining the “best in class” healthcare services.

**VENDOR SELECTION CRITERIA:**

The contract being utilized as part of the joint purchasing agreement has been advertised and awarded in accordance with the procurement procedures of the Chicago Public Schools (CPS) Procurement staff specification # 16-350024 and approved under the Chicago Board of Education board report # 16-0824-PR13. Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District’s competitive bidding requirements.

**MBE/WBE COMPLIANCE:**

The Office of Procurement Services has reviewed the proposed renewal and has determined that BlueCross BlueShield of Illinois has complied with the Board Approved Participation Plan and will utilize the following firms:

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board’s Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
