We look forward to working together for the benefit of our students, and to securing appropriate funding in order to accomplish that. We wish a wonderful summer to those that will be off until the fall semester, and a restful three-weeks interim to those colleagues working this summer session. We have plenty of goals to achieve, and your new CCC Faculty

Council officers are ready to assume this challenge. Thanks for listening, and let us keep working together to strengthen our shared governance at the City Colleges of Chicago.
