I. <u>CALL TO ORDER</u>

Vice Chair Swanson began by calling to order the March 12, 2020 Regular Board Meeting at 2:25 p.m.

III. <u>WELCOME</u>

Vice Chair Swanson welcomed everyone to the Board meeting and noted that Chair Massey was participating by phone, which is permissible under Article 1.5.3 Sections A-C of the Board Bylaws, provided there was quorum in the room, which was confirmed by the roll call.

Vice Chair Swanson noted that she would be facilitating the meeting, but invited Chair Massey to say a few words.

Chair Massey announced that the Board would be considering the reappointments of Chancellor Salgado and Provost Potter. The Chair commented on the Chancellor and Provost's commitment to the students, faculty, and staff of City Colleges. Chair Massey concluded his remarks by acknowledging the loss of Issac Vazquez, student at Daley College, and Jaya Beemon, student of Malcolm X and Kennedy-King College. The Chair extended the condolences of the Board to the students, professors, friends, and family of Daley, Malcolm X, and Kennedy King.

IV. <u>STUDENT TRUSTEE REPORT</u>

Student Trustee Alexander gave his report, detailing various activities and events across the District.

V. CHANCELLOR'S UPDATES

Chancellor Salgado affirmed City Colleges' work with the City of Chicago and the Chicago Department of Public Health (CDPH) to respond to COVID-19. At this time, the Chancellor noted, City Colleges would not be closing, based on recommendations from local health authorities. Guidance to faculty, staff, and administrators had been sent out to continue planning for online learning in the event of a closure. Chancellor Salgado also recognized that not all students have access to technology resources, and that not all courses can be easily moved to a virtual environment. The Chancellor noted that the presidents and colleges were working with District Office to explore options and minimize disruption to learning, while being mindful of the changing circumstances. Chancellor Salgado encouraged the City Colleges community to be gentle and flexible with one another, and themselves.

Chancellor Salgado commented that his team was meeting regularly, and that each college has a response team to assist in coordination. The Chancellor also noted that hazard plans have been updated to incorporate COVID-19. Chancellor Salgado urged everyone to continue washing hands and staying home if they are sick, noting that hand sanitizer was readily available at all City Colleges locations. Travel guidance for faculty and staff has been issued, and a website with information had been launched (www.ccc.edu/coronavirus) to supplement CDPH. Chancellor Salgado urged everyone to keep up to date with CDPH updates and information.

In closing, the Chancellor affirmed the privilege to serve and work at City Colleges, voicing his and Provost Potter's gratitude and commitment to continue to working with students, faculty, and staff at City Colleges.
