PREFERRED PROVIDER ORGANIZATION MEDICAL PLAN (PPO) HEALTH CARE SERVICE CORPORATION D/B/A BLUE CROSS BLUE SHIELD OF ILLINOIS (BCBS) MDx MEDICAL INC., d/b/a SAPPHIRE DIGITAL OFFICE OF HUMAN RESOURCES AND STAFF DEVELOPMENT DISTRICT WIDE

THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorize the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to execute an agreement with Health Care Service Corporation, a Mutual Legal Reserve Company d/b/a Blue Cross Blue Shield of Illinois ("BCBS") for BCBS to provide administration services for City Colleges of Chicago's ("CCC") self-insured Group PPO Medical Plan for the period from January 1, 2021 through December 31, 2023 at a total cost not to exceed \$1,000,000 annually.

The Chancellor also recommends that the Board of Trustees authorize the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to execute an agreement with Health Care Service Corporation, a Mutual Legal Reserve Company d/b/a Blue Cross Blue Shield of Illinois ("BCBS") and MDx Medical Inc., d/b/a/ Sapphire Digital ("Sapphire"). Through this 3-way agreement, Sapphire shall provide administration services for the Member Rewards (Health Advocacy Solutions) program that is one segment of CCC's self-insured Group PPO Medical Plan for the period from January 1, 2021 through December 31, 2021 at a total cost not to exceed \$10,000 annually.

TERM:

The term of the agreement between BCBS and CCC with will begin on January 1, 2021 and will continue through December 31, 2023 with two (2) options to renew for one (1) year each.

The term of the 3-way agreement between BCBS, Sapphire Digital, and CCC with will begin on January 1, 2021 and will continue through December 31, 2021 with four (4) options to renew for one (1) year each.

SCOPE OF SERVICES:

BCBS provides self-insured claims administration services for eligible active and retired employees of CCC for employees that are covered under PPO. Sapphire provides Health Advocacy Solutions administrative services for their members rewards program that gives participants the ability to earn rewards resulting from actions that reduce claims costs to CCC. This program is run transparently through BCBS PPO Group Medical plan.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The Office of Human Resources participated in a Joint Request for Proposal (RFP) with the City of Chicago and several sister agencies. It is advantageous to the District to leverage the joint purchasing agreement with these multiple organizations. This leverage resulted in cost savings on the administrative fees while maintaining the "best in class" health care services.

VENDOR SELECTION CRITERIA:

The contract being utilized as part of the joint purchasing agreement has been advertised and was awarded in July 2020 in accordance with the procurement procedures of the City of Chicago (Specification No. CBO 2019-001).

Pursuant to State law, contracts for goods and services procured from another governmental entity are exempt from the District's competitive bidding requirements.

Due to the high degree of professional and technical skill, pursuant to State law, Sapphire Digital's professional services are exempt from the District's competitive bidding requirements.

MBE/WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed proposal with Sapphire Digital and recommends a waiver of the Board Approved Participation Plan due to the nature of the services (administrative services for members reward program) and the absence of subcontracting opportunities.

The Office of Procurement Services has reviewed the proposal and has determined that BCBS has complied with the Board Approved Participation Plan and will utilize the following firms:
