Non-Bargained For Employee Increases up to 2.5% (the "NBF Increase")

As July 5, 2021, each employee that was active in a full-time or part-time Administrator or NBF job family prior to July 1, 2020, and is in active status as of the date the NBF Increase is paid, shall receive a base salary increase of up to 2.5%; provided that, (i) eligible non-bargained for employees that have received a permanent base salary increase of less than 2.5% since July 1, 2020 (the "Initial Increase") shall only receive the difference between the NBF Increase and the Initial Increase; and (ii) eligible non-bargained for employees that have received a permanent salary increase equal to or greater than 2.5% since July 1, 2020 shall receive no NBF Increase.
