SIGN LANGUAGE INTERPRETATION SERVICES CHICAGO AREA INTERPRETER REFERRAL SERVICE (CAIRS) OFFICE OF ACADEMIC AND STUDENT AFFAIRS (RENEWAL) DISTRICT WIDE

THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to exercise the option to renew the agreement with Chicago Area Interpreter Referral Service (CAIRS) for sign language interpretation services, for the period from August 1, 2021 through July 31, 2022, at a total cost not to exceed \$300,000.

ORIGINAL TERM:

The term of this agreement commenced on August 1, 2019 and will end on July 31, 2021 with an option to renew for an additional one (1) year period.

RENEWAL TERM:

The renewal term of this agreement shall commence on August 1, 2021 and will end on July 31, 2022.

SCOPE OF SERVICES:

Chicago Area Interpreter Referral Service (CAIRS) will provide sign language interpretation services for students, staff, and events open to the public as needed when staff sign language interpreters are unavailable. Interpretation services include classroom, one-on-one meetings, clinicals, presentations, events, etc. Services will be provided on-campus, off-site, or remotely depending on the need.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Sign language interpretation is a requirement to meet accessibility standards and federal guidance

for the deaf and hard of hearing community pursuant to the Americans with Disabilities Acts of 1990 and subsequent amendments. The CAIRS will provide adjunct service to complement existing staff sign language services. Adjunct services enable the City Colleges of Chicago to remain in compliance with federal law.

VENDOR SELECTION CRITERIA:

Specifications prepared by District Office Procurement staff were publicly advertised May 6, 2019 as a Request for Sealed Bid #SN1902. The bid was sent to eight (8) vendors and a pre-bid conference was held on May 10, 2019, after which responsive and responsible bids were received on May 24, 2019 from the following four (4) vendors: 1) Chicago Hearing Society – a division of Anixter Center, 2) Sorenson Communications, LLC, 3) Hi-5 Access Interpreting and Communication Services, and 4) Chicago Area Interpreter Referral Service (CAIRS).
