#### **BENEFIT TO CITY COLLEGES OF CHICAGO:**

The LR Mate 200 iD/4S robot, CERT training platform and instructor certification training provides students and instructors with curriculum and instructional guides. As the Engineering and Computer Science Center of Excellence, the tooling package move engineering and advanced manufacturing concepts from theory to practice.

#### **VENDOR SELECTION CRITERIA:**

#### MBE/WBE COMPLIANCE:
