ANNUAL PLUMBING AND PIPING REPAIR WORK CONTRACT T&J PLUMBING CORE MECHANICAL INC. OFFICE OF ADMINISTRATIVE AND PROCUREMENT SERVICES (RENEWAL OPTION) DISTRICT WIDE

THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreements, to exercise the option to renew the depends upon requirement (DUR) agreements with T&J Plumbing and Core Mechanical Inc. for plumbing and piping repair services for the period from April 5, 2021 through April 4, 2022, at a total cost not to exceed \$400,000.

ORIGINAL TERM:

The term of the agreement commenced on April 5, 2018 and will end on April 4, 2021, with two (2) options to extend for one (1) year each.

RENEWAL TERM:

The first renewal term of the agreement shall commence on April 5, 2021 and shall end on April 4, 2022 with one (1) remaining option to renew for one (1) year.

SCOPE OF SERVICES:

T&J Plumbing and Core Mechanical Inc. will provide routine and emergency repairs and parts for the colleges as needed. Based on review of past needs of the campuses and unpredictable equipment failures often needing emergency repairs and or parts, it was recommended to award the work to T&J Plumbing and Core Mechanical Inc. This allocation of funds is based on past pricing, response time to emergency and routine requests, and historical usage of routine

and emergency repairs as needed to maintain the plumbing and piping systems.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Each college will have access to obtain routine and emergency repairs as needed to maintain plumbing and piping systems within each building in a timely manner.

VENDOR SELECTION CRITERIA:

Pursuant to Board Reports #33424, adopted on April 5, 2018, and #33921 adopted on February 13, 2020, the Board authorized the execution of agreements with T&J Plumbing and Core Mechanical to provide plumbing and piping repair services on an as needed basis for the district. Specifications were prepared by District Procurement staff, and publicly advertised on February 6, 2018 to solicit bids to provide hourly rates for the required work. Fifty (50) firms were contacted; a pre-bid conference for #SJ1802 was held on February 8, 2018. Four firms responded:

The Office of Administrative and Procurement Services staff reviewed the bids submitted by the most responsive and responsible bidders, and reported that T&J Plumbing and Core Mechanical Inc. met the plumbing and piping repair specifications and are recommended for award.
