THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to authorize the execution of an agreement with Inner City Muslim Action Network (IMAN) for program case management services for the Weekend Warrior Program at Daley College for the period from March 4, 2021 through March 3, 2022 at a total cost not to exceed \$75,000.

TERM:

The term of this agreement shall begin on March 4, 2021 and end on March 3, 2022.

SCOPE OF SERVICES:

Inner City Muslim Action Network (IMAN) will provide recruitment services, case management, behavioral health services, visual arts programming, enrichment excursions, meals, transportation, and a program coordinator for Daley College's Weekend Warrior Program, as well as quarterly reporting on program metrics. Recruitment efforts will focus on returning citizens and individuals exposed to/close to violence, especially those not considering pursuing college. The Weekend Warrior Program provides extensive focused time on campus, providing culturally relevant enrichment programming, trauma-informed wraparound services, and college-level programming on weekends (every Friday, Saturday, and Sunday of the semester) to remove students from exposure to further violence and potential recidivism. Programming will run spring, summer and fall semester.

BENEFIT TO CITY COLLEGES OF CHICAGO:

IMAN will allow City Colleges to offer "whole person" approach to violence reduction and career training in Advanced Manufacturing for any individuals looking to avoid recidivism and violence while expanding the implementation of the successfully piloted Weekend Warrior program. Students will have access to wraparound services and supports. Upon completion of the program, students will have the opportunity to progress further in their training and education at Daley College.

VENDOR SELECTION CRITERIA:

In accordance with sole source policy procedures, this service is exempt from the District's competitive bidding process.

MBE/WBE COMPLIANCE:

The Office of Procurement Services has reviewed the proposed agreement and recommends a waiver of the Board Approved Participation Plan due to the nature of the service.

GENERAL CONDITIONS:

Inspector General- It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
