RESOLUTION AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT WITH THE ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY AND HAROLD WASHINGTON COLLEGE

WHEREAS, the Intergovernmental Cooperation Act, 5ILCS 220 et seq., as amended authorizes public agencies to enter into agreements and contracts to perform any governmental service, activity, or undertaking authorized by law upon approval of their respective governing bodies; and

WHEREAS, the Illinois Department of Commerce and Economic Opportunity - Job Training and Economic Development (JTED) will partner with Harold Washington College to provide services including, but not limited to address the economic impacts experienced by employers and individuals, either under-employed, unemployed, or under-represented facing one or more barriers to employment, by providing career pathway opportunities and support services needed for successful entry and advancement into the labor force. Harold Washington College will support students to be trained and employed in the target industries most impacted by the COVID-19 pandemic that are seeking a skilled workforce.

- 30 students in year one and 30 in year two will enroll and work toward Basic Certificates in hospitality, accounting clerk, and human resources.
- 10 students in year one and 10 in year two will work toward micro-credentialing in hospitality, as front desk representatives, and accounting clerk positions as well as industry certificates to prepare them for positions in guest services and guest room attendants.

WHEREAS, Harold Washington College will manage and administer the Program; and

WHEREAS, the Illinois Department of Commerce and Economic Opportunity will provide up to \$475,000.00 for operating costs from 05/01/2022 through 04/30/2024.

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois, authorizes the Chair, upon final approval of the General Counsel as to the legal form of such an agreement, to execute an Intergovernmental Agreement with the Illinois Department of Commerce and Economic Opportunity and Harold Washington College to provide training, for the period of May 1, 2022 through April 30, 2024, in which the Illinois Department of Commerce and Economic Opportunity agrees to provide up to \$475,000.00 for use in connection with the program.
