The term of the purchase shall begin on November 1, 2022.

SCOPE OF SERVICES:

We would like to purchase 2 tractors and 2 48- or 53-foot Trailers with Rush Truck Center. This will enhance student practice and training experience with a more modern vehicle.

BENEFIT TO CITY COLLEGES OF CHICAGO:

To purchase the vehicles allows us to expand the CDL A program to increase the enrollment for the class. We have a waiting list every semester for the class. The students will apply hands on training with modern vehicles. The modern vehicles enhance CDL training and will support Olive-Harvey College in increasing the number of students earning credentials of value in the transportation industry.

VENDOR SELECTION CRITERIA:

This is a Sourcewell consortium truck and trailer purchase. The company International, Ruch Truck Center.

MBE/WBE COMPLIANCE:

The office of Procurement Services has reviewed the above referenced purchase and determined there are no MBS or WBE subcontracting opportunities due to the sole source nature of this transaction. Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
