THE CHANCELLOR RECOMMENDS:

That the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to authorize the execution of an agreement with ANIXTER CENTER for SIGN LANGUAGE INTERPRETATION SERVICES the period from August 1, 2022 to July 31, 2024, at a total cost not to exceed \$500,000.

TERM:

The term of this agreement shall begin on August 1, 2022 and shall end on July 31, 2024, with options to renew for two (2) one (1) year periods or one (1) two (2) year period.

SCOPE OF SERVICES:

Anixter Center will provide sign language interpretation services for students, staff, and events open to the public as needed when staff sign language interpreters are unavailable. Services will be provided on-campus, off-site, or remotely depending on the need.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Sign language interpretation is a requirement to meet accessibility standards and federal guidance for the deaf and hard of hearing community pursuant to the Americans with Disabilities Acts of 1990 and subsequent amendments. The Anixter Center will provide adjunct service to complement existing staff sign language services. Adjunct services enable the City Colleges of Chicago to remain in compliance with federal law.

VENDOR SELECTION CRITERIA:

Specifications prepared by District Office Procurement staff were publicly advertised March 28, 2022 as a Request for Sealed Bid #WM2201. The bid was sent to five vendors and a pre-bid conference was held on April 5, 2022, after which responsive and responsible bids were received on April 19,2022 from the following two (2) vendors: 1) Anixter Center, 2) 5Star Interpretation Services.
