THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel of the legal form of such agreements, to amend the agreement with AT&T Corporation to reduce City Colleges of Chicago Minimum Annual Revenue Commitment [MARC] and extend The MARC agreement to be conterminous until October 31, 2024 to align with and existing AT&T telecommunication services agreements for the same period of November 1, 2013 through October 31, 2024 for a total cost not to exceed \$14,490,548.

TERM:

The term of this agreement commenced on November 1, 2013 and will continue through October 31, 2024

SCOPE OF SERVICES:

AT&T Corporation (AT&T) offers unlimited data plans for a flat monthly cost for all MiFi devices issued. The Office of Information Technology (OIT) has consolidated multiple agreements with AT&T to provide Centrex lines, local telephone services, Enterprise Messaging Services, HD Video Conferencing, and Data and Internet Services to support the District's telecommunications platform, as well as a secondary data line network connection for improved internet access and reliability.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The unlimited data plan allows students and faculty to connect to the internet for uninterrupted remote and online learning. The District will be provided with telecommunications and data service. From 2013 to 2020, CCC received a volume discount of 20% as long as annual costs were above \$250,000.00 annually. AT&T has since reduced this commitment to \$70,000.00 annually for the years of 2021-2024.

VENDOR SELECTION CRITERIA:

Pursuant to State law, purchases and contracts for the use, purchase, delivery, movement, or installation of telecommunications and inter-connect equipment, software, and services are exempt from the District's competitive bidding requirements.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
