RESOLUTION

AUTHORIZING TRUST AGREEMENTS WITH THE STATE OF ILLINOIS AND THE CAPITAL DEVELOPMENT BOARD FOR CONSTRUCTION PROJECTS OFFICE OF ADMINISTRATIVE AND PROCUREMENT SERVICES

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220 et seq., as amended, authorizes public agencies to enter into agreements and contracts to perform any governmental service, activity, or undertaking authorized by law upon approval of their respective governing bodies; and

WHEREAS, the Capital Development Board (CDB) is an agency of the State of Illinois created pursuant to 20 ILCS 3105 et seq. which is responsible for managing construction projects for which money has been appropriated or authorized by the General Assembly; and

WHEREAS, the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois ("Board") was created pursuant to the Public Community College Act of the State of Illinois, 110 ILCS 805 et seq., as amended; and

WHEREAS, the Board has determined that it is desirable, advantageous and in the public interest to undertake six projects under the City Colleges of Chicago's Capital Improvement Program in conjunction with the CDB and therefore Trust Agreements which delineate the objectives, duties and responsibilities of the CDB and the District are necessary for each of the following six projects:

- 1. Daley College Parking Lot and Site Improvements
- 2. Harold Washington College Piping Replacement and Plumbing Improvements
- 3. Kennedy-King College Dawson Technical Institute Welding Lab Renovation
- 4. Olive-Harvey College Ring Road and Parking Lot Repaving
- 5. Truman College Roof Replacement
- 6. Wright College Roof Replacement; and

WHEREAS, the CDB has committed to provide up to seventy-five percent (75%) of the cost of each project to finance the six projects and CCC is required to provide a local match of at least twenty-five person (25%) of each project to finance the balance of project costs;

WHEREAS, the Board desires that the CDB manage the projects; and

WHEREAS, the Board agrees to transfer funds in the amounts below to the CDB under said Trust Agreements;

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of the City Colleges of Chicago, authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to execute Trust Agreements with the Capital Development Board for the development and execution of these six projects under City Colleges of Chicago's Capital Improvement Plan.
