**THE CHANCELLOR RECOMMENDS:**

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreement, to authorize the execution of a no change in fee extension to an agreement with Persistence Plus to provide behavioral science-based nudging and professional development for a period commencing no sooner than October 7, 2021, through October 6, 2022. This board will amend original Board Report #34333 to extend the end date of the said contract until June 1, 2023, at a total cost not to exceed \$85,000.

**TERM:**

The amended term of the purchase shall begin October 7, 2021, and shall end on June 1, 2023.

**SCOPE OF SERVICES:**

1. Persistence Plus will design and deliver interactive and personalized mobile nudges to up to 6000 students in health career pathways to increase college persistence and success throughout the 2021-23 academic year
2. Persistence Plus will engage Malcolm X College faculty and staff in sustained professional development to integrate behavioral science into their program design and student communications.

**BENEFIT TO CITY COLLEGES OF CHICAGO:**

This service will improve rates of retention and completion, provide dedicated support to students, and build the capacity of faculty and staff to develop and nurture trusting and support relationships with students. Malcolm X College anticipates this intervention serving as a blueprint for other City Colleges to adopt and implement.

**VENDOR SELECTION CRITERIA:**

In accordance with sole source policy procedures, this service is exempt from the District's competitive bidding process.
