THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon approval of the General Counsel to the legal form of such agreements, to execute an agreement with Snap On Inc. for the purchase of various tools and equipment to support the various programs at Truman College for the period of November 3, 2022 through June 30, 2023 at a total cost not to exceed \$602,482.83.

TERM:

The term of the purchase shall begin on November 3, 2022 and end on June 30, 2023 with option to renew for two (2) additional one (1) year periods ending June 30, 2025.

SCOPE OF SERVICES:

Snap-on Industrial will provide required tools and equipment to support the automotive programs at Truman College and grant the college Snap-on Certification Center Status. The College will be able to procure the appropriate certification program tools and equipment for student instruction under the Sourcewell consortium contract. The immediate need is to procure the following items for Truman College utilizing HEERF funds for FY22:

NC3/Snap-on Certification Center Status is reflective of all items listed below. Please note pricing is based on the Sourcewell contract and includes delivery and offload with CCC-approved installation. Certification Kits with accessories and additional facility upgrades including up-to-date shop equipment are also included.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The use of Snap-on Industrial will allow City Colleges to train the students on the preferred industry partner tools and equipment. This approval will also assist with alignment of the programs across the District. The instructional programs will be utilized to obtain NC3 and NATEF certifications for the students as well as provide professional development opportunities in continuing education.

VENDOR SELECTION CRITERIA:

This is a Sourcewell Consortium purchase. The contract being utilized as a part of Sourcewell (formerly National Joint Powers Alliance) approved under Board Report #29816 and #32583. Sourcewell contract 013020-SNP gives access to the following types of goods and services:

- Hand tools
- Shop & garage equipment
- Under car equipment
- Vehicle diagnostics
- Tool storage
- Power tool
- Vehicle lifts
- Tool control & asset management
