THE CHANCELLOR RECOMMENDS:

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to authorize the execution of an agreement with Advanced Technologies Consultants for the purchase of mechatronics, electricity and robotics training equipment for the period from November 7, 2022 through June 30, 2023, at a total cost not to exceed \$339,426.

The term of this purchase shall begin on November 7, 2022 and shall end on June 30, 2023, with the equipment warranty to extend for three years after the actual purchase date.

SCOPE OF SERVICES:

Advanced Technologies Consultants is an authorized dealer for Festo-Didactic and will provide Wilbur Wright College with mechatronics, electricity and robotics training equipment for use in the CNC Manufacturing program at the Wilbur Wright Humboldt Park Campus. This purchase will provide students with hands on experience with state-of-the-art equipment

BENEFIT TO CITY COLLEGES OF CHICAGO:

The purchase of this equipment will be used to support the CNC Manufacturing program at the Wilbur Wright Humboldt Park Campus.

VENDOR SELECTION CRITERIA:

Specifications prepared by District Office Procurement staff with input from Wright College and Daley College and was publicly advertised September 16, 2022 as a Request for Sealed Bid #WM2206. A pre-bid conference was held on September 21, 2022, and the bid opening was held on September 30, 2022. The District received one bid from Advanced Technologies Consultants.
