The Chancellor thanked everyone who organized the Faith and Education breakfast. Faith leaders from across the city came out to hear from Chicago public schools and

City Colleges about the opportunities each has to offer.

Chancellor Salgado went on to thank Jacinta Epting, whose last day is today, for her efforts in heading the Procurement Office.

Chancellor went to uplift all the partnerships throughout the institution that allow us to better serve our student populations within the city. Some of these partnerships include Eli's Cheesecake and Wright College, Illinois Department of Juvenile Justice, Chicago Department of Family Support Services, and One Million Degrees.

Today, the Board will consider an expansion of our telework policy for bargain for employees.

City Colleges is committed to negotiating in good faith with each of our professionals and faculty unions to finalize their respective collecting bargaining agreements.

City Colleges of Chicago is collaborating with the City of Chicago Department of Family Support Services in the Office of Emergency Management and Communications to provide shelter for new arrivals operated by the City of Chicago as well as adult education programs here and throughout the state.
