
Equity Goals

55% by FY32


Short-term Goal: Achieve 30% progress to goal by FY26

4-Year Outcome Measure Cohorts, FA22 Status (Latinx Females and Latinx Males)




First-Year Fall-to-Fall Retention

- While equitable completion rates represent the "finish line" for our ambitious institutional goal, student success starts early in the student lifecycle.
- We lose about half of our first-year, credential-seeking students of color before they get to their second fall at CCC

In order to begin closing outcome gaps, CCC must begin by focusing on increasing first-year retention for Black and Latinx students.

Project Objectives

- Improve first-year fall-to fall retention rates for Black and Latinx credit, credential-seeking students.
- Invest financial resources into colleges who develop and execute successful Black and Latinx student retention strategies and practices, with the hope and intention that these investments will help colleges build on initial promise and success, ultimately leading to scalable solutions that can be leveraged throughout the District.

Project Timeline

- Feb 2023: Project Launch
- March/April 2023: Colleges confirm subcohort retention targets for Black and Latinx FY students
- Feb/March 2023 Aug 2023: Colleges execute retention strategies
- Sep Oct 2023: Colleges prepare retention outcome reports + presentations
- Nov Dec 2023: Report/presentation review
- Jan/Feb 2024: Announcement of awards

Appendix

Retention Calculation Methodologies

► FY Student Fall-to-Fall Retention Cohort

- All credential-seeking students who are new to CCC, enrolled in credit <u>in a given fall</u>,
- o Includes [1] transfer-ins, if they have never attended CCC, [2] summer starters who also enroll in the fall, [3] and prior Early College students who have matriculated to credential-seeking,
- Excludes current Early College students
- o Students who earn any credential prior to their 2nd fall term are removed from calculation

▶ FY Student Spring-to-Fall Retention Cohort

- All credential-seeking students who are new to CCC, enrolled in credit <u>in a given spring</u>
- o Includes transfer-ins, if they have never attended CCC; summer starters who also enroll in the fall; and prior Early College students who have matriculated to credential-seeking
- Excludes current Early College students
- O Students who earn any credential prior to their 1st fall term are removed from calculation
