I. CALL TO ORDER

Vice Chair Swanson began by calling to order the March 2, 2023, Regular Board Meeting at 2:00 p.m.

III. WELCOME

Vice Chair Swanson began by welcoming everyone and stating that March is Women's History Month. "This month we celebrate and recognize the achievements made by women and I want to recognize all the incredible women of city colleges both here in this room and across the colleges and campuses.

VI. CHANCELLOR'S UPDATES

Chancellor Salgado began by recognizing the teamwork that is required to accomplish goals across the institution. He thanked Vice Chancellor Williams for building an operation within the district now that has not been seen in the past. Work between the College Deans and Chancellor Williams's office makes the goals possible.

Chancellor recognized March as Women's History Month and echoed Vice Chair Swanson's thanks and gratitude to the women of City Colleges, the students, staff, and board.

Chancellor reflected on the events that happened in February including, a delegation sent from each college and the District Office to the Achieving the Dream Conference held here in Chicago. Achieving the Dream is a network of 300 community colleges across the country dedicated to improving their programs and practices to better serve students. City Colleges of Chicago had representatives from every college in attendance.

Chancellor Salgado announced that the City College and the City Colleges Foundation launched a new fellowship program. The Timuel D Black Junior Scholarship and fellowship program is inspired by the late City Colleges Professor Timuel D. Black Jr's remarkable career. This opportunity came through the City College's Foundation in honor of Black History Month, with the donation of 1,700 culinary books from the family of Free Frank McWorter to Kennedy-King College and the Washburn Culinary and Hospitality Institute.

City Colleges co-hosted a free two-day Chicago Caregivers Course Symposium at Malcolm X. Chancellor Salgado thanked Malcolm X President David Sanders for his engagement in this course and event to enter a new approach to supporting caregivers of veteran police firefighters, first responders, and trauma victims. The Symposium served as a pilot four-week course that will be offered beginning this summer and taught by faculty from the University of Chicago and City Colleges of Chicago. Chancellor Salgado recognized Vice Chancellor of Enrollment Daryl Williams for his leadership in moving City Colleges to the forefront of this effort with the University of Chicago.

Chancellor Salgado recognized Harold Washington's President Daniel Lopez for representing City Colleges at a round table in Washington DC, organized by Haku Hispanic Associations of College and Universities, which include higher education leaders from across the country. They will be having their conference here this coming fall along with included officials from the US Dept of Homeland Security to discuss the department's priorities related to Hispanics serving educational institutions which many of our colleges are today.

Chancellor Salgado recognized the roadmap work being done. There will be 14 Spotlight Days for middle school and high school students that are at Chicago Public Schools. One was already held at Daley College and Olive Harvey, and at Malcolm X.

Enrollment is currently beating state and national averages and hard work is being done to keep City Colleges affordable and assessable to students. The hard work being done to have scholarship and grant programs available. Tuition has not been increased since 2016. No change will be made to tuition this fall, for the eighth year. Instead, a process has been launched to reevaluate tuition costs that mirrors the process from 2019 and 2020. In 2020 a tuition recommendation was presented but put on pause due

to the pandemic, so that will be re-evaluated again this fall.

Chancellor Salgado ended by thanking Chief Information Officer Jerrold Martin for the presentation on Information Technology. Investment in the Information Technology is critical to the district because it undergirds many of the efforts being done to create an exceptional student experience.

Trustee Darrell Williams gave the March 2023 Committee Report.

The Finance and Administrative Services committee was provided with two updates and reviews. CFO Rodriguez introduced PFM director Danny Nelson. PFM is the investment manager for the City College's working cash short-term and restricted Capital funds, and Mr. Nelson addressed the committee's questions on portfolio performance. The committee was provided an update on CCC's Information Technology initiatives from Chief Information Officer Jerrold Martin. The current phase is focused on Recruitment and admissions activities and as part of CCC's overall strategic plan. This new system is designed to streamline and improve the communication system with current and prospective students.

Additionally, we reviewed the resolutions Personnel items, resource development report, agreements purchases, and legal invoices included on today's Finance and Administrative Services agenda as part of the consent agenda to this March 2nd, 2023, regular board meeting.
