Chair Massey called to order the November 2, 2023, Regular Board Meeting at 2:00 p.m.

III. <u>WELCOME</u>

Chair Massey welcomed everyone to the November Regular Board Meeting. Chair Massey thanked Trustee Williams and Lopez for representing the board at the Wilbur Wright Higher Learning Commission Accreditation meeting. Trustee Williams also represented the board at Governor Pritzker's press conference and the 1619 project conversation at Kennedy King College.

Chair Massey congratulated CFO Maribel Rodriguez for being named a finalist for the 2023 Chicago CFO of the year Award.

District FC4 President Viggy Alexanderson will be attending today's meeting remotely.

IV. <u>STUDENT TRUSTEE REPORT</u>

Student Trustee Goldbloom gave brief remarks about District initiatives.

V. <u>CHANCELLOR'S UPDATES</u>

Chancellor Salgado began by recognizing November as Native American Heritage Month.

Fall enrollment numbers are strong as discussed by Vice Chancellor Darryl Williams during the committee meeting today, and which were announced on Monday by the IL Community College Board.

Enrollment continues to trend upwards, surpassing state and national averages for community colleges, including strong gains for Black and Latinx male students in particular.

Our ICCB Total Headcount enrollment (Credit and Adult Education combined) for Fall 2023 increased by 12.7% compared to last fall, which is more than double the state average.

All seven colleges experienced an increase in total ICCB headcount enrollment from last year. Credit headcount is up 8% compared to the prior year. This is nearly double the undergraduate national average. Adult Education is up 27% compared to the prior year. New student enrollment increased by 12% and continuing student enrollment increased by 16%. Black male student enrollment is up 16% this fall. Latinx male student enrollment is up 9% this fall.

Several factors contribute to these outcomes, including: our focus on performance management of admitted to enrolled yield rates, equity and economic mobility access programs, such as: Future Ready, the Workforce Equity Initiative, and Fresh Start, the Chicago Roadmap with the Chicago Public Schools, growth in high-demand programs, and process enhancements, especially in the adult education department.

Intelligent.com, a resource for higher education program rankings, honored six City Colleges of Chicago as among the Best Community Colleges in Illinois for 2024.

The site considered academic quality, graduation rates, affordability, ROI, and the breadth of student resources when creating its ranking. (Note: Malcolm X College came in highest among City Colleges, at #9 on their list.)

We were also fortunate to host Governor Pritzker at two colleges this past month. The Governor came here to Harold Washington College to announce a new partnership with the state's Department of Innovation & Technology (DoIT) to launch a paid trainee program, creating a pipeline of tech talent for the state.

Trainees will receive a minimum yearly salary of \$54,000 from the state while pursuing tracks in one of five high-need concentration areas of cybersecurity, networking, coding and database, end user computing and enterprise infrastructure.

The Governor also visited Malcolm X College to discuss a new state scholarship program that will help support students pursuing tech careers.

We hosted two meetings to ensure that opportunities at City Colleges are reaching our city's diverse communities, including a Faith in Education Breakfast with Mayor

Johnson and CPS CEO Martinez last week, and this week, a breakfast for community partners from across the city to learn about our free adult education offerings.

We also wrapped up two weekends of hiring fairs at all of our colleges in partnership with the office of Alderman and Education Committee Chair Jeanette Taylor.

Chancellor Salgado went on to highlight a couple of members of the community.

• HWC advisor Anna Koomalsingh was selected as a 2023 Veteran Champion of the Year in Higher Education by "G-I Jobs". These are advocates who go above and beyond to help student veterans and military-affiliated students and their families succeed in college.

Vice Chancellor Darryl Williams reported on enrollment. The ICB total headcount for fall 2023 has increased 12.7% compared to last fall. It's double the state average and nearly double the national average. Our Black and Latinx experienced incredible increases outpacing state and national trends.
