TERM:

The term of this agreement shall begin on February 3, 2023 and shall end on December 31, 2023.

SCOPE OF SERVICES:

Services related to insurance and risk matters and the training of City College's Compliance Officer and Director of Risk Management.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Mr. Passarelli is an expert concerning insurance and risk management matters and is the former City Colleges of Chicago's Director of Risk Management. Over his years of service, Mr. Passarelli implemented a substantial insurance and risk management structure across the seven colleges and the district office. Mr. Passarelli is uniquely qualified to assist with risk management matters and the training of City College's new Compliance Officer and Director of Risk Management.

VENDOR SELECTION CRITERIA:

In accordance with the sole source policy procedures, this request for services is exempt from the District's competitive bidding process.

MBE/WBE COMPLIANCE:

Procurement services has reviewed the proposed agreement and recommends a waiver of the Board Approved Participation Plan due to the nature of the services (Consultant Services).

GENERAL CONDITIONS:

Inspector General- It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General’s authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable provisions of the Board’s Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year is subject to appropriation in the subsequent fiscal year.
