THE CHANCELLOR RECOMMENDS:

that the Board of Trustees approves the issuance of a purchase order to Core Mechanical to provide all labor and materials necessary to complete the replacement of the Weil pumps and related piping in the Phase II building at Truman College for the period of February 2, 2023 through June 30, 2023 at a total not to exceed cost of \$127,045.

TERM:

The term of the purchase will begin on February 2, 2023 and shall continue until fully accepted by Truman College or no later than June 30, 2023.

SCOPE OF SERVICES:

Core Mechanical shall provide labor and materials as necessary to replace two failed pumps and related piping. Work to included but not limited to the following.

- Demo and remove existing pumps and piping
- Furnish and install two new Weil pumps with hydraulic performance double opposed mechanical seals.
- Upgrade power for two main disconnects with independent circuits, motor contractors, and overload protection.

BENEFIT TO CITY COLLEGES OF CHICAGO:

Per Board Report 33981, adopted on June 4, 2020, the District entered into an agreement with Core Mechanical for HVAC, Mechanical, and Piping Repair services for as needed annual maintenance and routine and emergency repairs. The existing pumps in the Phase II building have failed and are beyond repair. Replacement of the pumps will allow operations to continue without service interruption. A temporary pump was installed to allow operations to continue in the interim.

The Office of Administrative and Procurement Services has reviewed this request for services and has determined that it would be in the best interest of the District to use the HVAC, Mechanical, and Piping Repair services contract as the delivery method for completing this work to ensure that the project is performed in a timely manner and to continue operations at the College.

VENDOR SELECTION CRITERIA:

Pursuant to board report 33981, specifications were prepared by District Procurement staff, and publicly advertised on April 1, 2020, to solicit bids to provide hourly rates for the required work for a three (3) year period with an option to renew for two additional 1-year terms. Thirty-three (33) firms were contacted. Four firms responded: 1) Core Mechanical, Inc. 2) Delta Heating and Air Conditioning, Inc., 3) Autumn Construction Services. 4) Anchor Mechanical, Inc.

Staff from the Office of Administrative and Procurement Services reviewed the bids submitted by the most responsive and responsible bidders, and reported that Core Mechanical, Inc. and Delta Heating and Air Conditioning, Inc. met the Mechanical and Piping repair specifications.

The award to the two lowest responsive and responsible bidders is based on past pricing, response time to emergency and routine requests, and historical usage of routine and emergency repairs as needed to maintain mechanical and piping systems.
