**THE CHANCELLOR RECOMMENDS:**

that the Board of Trustees authorizes the Chair, upon final approval of the General Counsel as to the legal form of such agreements, to enter into an agreement with Sievert Electric for the purchase of a new scoreboard, shot clock and installation for the period beginning June 1, 2023 through December 31, 2023 at a total cost not to exceed \$30,644.

**TERM:**

The term of the agreement and purchase shall commence on June 1, 2023 and shall continue through December 31, 2023.

**SCOPE OF SERVICES:**

Sievert Electric will replace the scoreboard and shot clock that is currently in the gymnasium with an updated LED scoreboard.

**BENEFIT TO CITY COLLEGES OF CHICAGO:**

The Athletics department hosts numerous internal sporting and external events in our gymnasium. The display provides each team score, engages fans, and maximizes sponsor exposure while generating revenue for our school.

**VENDOR SELECTION CRITERIA:**

Consortium supplier OMNIA Partners is contracted with Daktronics for the manufacture, installation, repair and service of electronic scoreboards and shot clocks. Per their contract, Sievert Electric is an Authorized Dealer for sales, installation and service of Daktronics products. The contract being utilized as a part of OMNIA Partners (formerly National IPA) consortium agreement, approved under Board Reports

#29816 and #32583. Daktronics (and Sievert Electric as an Authorized Dealer) was awarded in accordance with their procurement procedures as detailed in RFP # 22-06, and approved under OMNIA Partner contract document # R220601

**MBE/WBE COMPLIANCE:**

The Office of Procurement Services has reviewed the proposed compliance plan and recommends a full waiver of the Board Approved MBE/WBE Contract Participation Plan due to the nature of the transaction (purchase & installation of digital scoreboard) and the absence of subcontracting opportunities.

**GENERAL CONDITIONS:**

Inspector General- It shall be the duty of each party to the agreement to cooperate with the Inspector General for City Colleges of Chicago in any investigation conducted pursuant to the Inspector General's authority under Article 2, Section 2.7.4(b) of the Board Bylaws.

Ethics – It shall be the duty of each party to the agreement to comply with the applicable Provisions of the Board's Ethics Policy adopted January 7, 1993, and as amended by the Board.

Contingent Liability – Pursuant to Section 7-14 of the Illinois Public Community College Act, all agreements authorized herein shall contain a clause that any expenditure beyond the current fiscal year.
