SCOPE OF SERVICES:

Midwest Computer Products, Inc will sell and install indoor and outdoor LED video walls, and applicable licensing, maintenance and support services associated with the video walls.

BENEFIT TO CITY COLLEGES OF CHICAGO:

The LED video wall upgrade will enhance visual communication, improve the reliability of the displays, as well as the accessibility and (visual) quality of information. The video wall displays are effective marketing and promotional tools for the Malcolm X campus. They also are used as information dissemination tools, informing our students, faculty, staff, and community about critical changes and announcements.

VENDOR SELECTION CRITERIA:
