## VI. CHAIR INTRODUCTION & WELCOME

Peggy Davis, Secretary of the CCC Board of Trustees stated that she will be chairing the decennial committee. Chair Davis stated the following:

In the spring of 2022, Illinois governmental agencies were tasked with studying local efficiencies and reporting recommendations regarding efficiencies and increased accountability to the county board in which the governmental unit is located.

As you know, the City Colleges of Chicago (CCC) is one of those agencies and we formed the required committee.

The Decennial Committee on Local Government Efficiency Act applies to local governments that levy taxes but excludes municipalities and counties. The committee must meet at least three times and submit a written report within 18 months of its formation.

The committee must be composed of:

1) The elected or appointed members of the governing board of the governmental unit.

2) At least 2 residents within the territory served by the governmental unit, who are appointed by the chair of the governing board, with the advice and consent of the governing board.

3) Any chief executive officer or other officer of the governmental unit.

## VII. CHARGE OF DECENNIAL COMMITTEE

Chair Davis stated that the charge of a decennial committee in Illinois is to study and report on local government efficiency.

The committee's duties include:

- Studying the local government's governing statutes, ordinances, rules, and procedures.
- Examining the local government's intergovernmental agreements and interrelationships with other local governments and the state
- Making recommendations for increased accountability and efficiency
- Preparing a written report to be presented to the county board

Members of the Decennial Committee have received the Decennial Committee on Local Government Efficiency Act and the CCC resolution creating the Decennial Committee.

## **Review of Applicable Law**

Karla Gowen, General Counsel/Board Attorney reviewed the applicable law and stated the following:

City Colleges of Chicago (CCC) and local governmental units. Beginning October 3, 2024, and ending December 23, 2024, the committee will inventory and review intergovernmental agreements and interrelationships with other governmental units to analyze, determine, and make recommendations for the purpose of gaining greater shared efficiencies with existing intergovernmental relationships and identifying new intergovernmental relationships. The potential approaches are, academic, operational, and governance/compliance.

What we will do in terms of the process is to have a presentation from someone appropriate on our staff who will discuss how we are thinking. When we say approaches, we are talking about the categories of our activities, so academic, operational, and governance. Someone from the staff will talk about each of those potential approaches as the statute refers to them. At the end, we are going to select one or two of those to study for this decennial year.

Provost Potter gave an overview of the Academic approach and potential topics.

Chief Financial Officer Rodriguez gave an overview of the operational approach and potential topics.

General Counsel Gowen gave an overview of the governance approach and potential topics.

## VIII. VOTE ON RECCOMENDATIONS

Committee Chair Davis suggested voting on two priorities to allow time to complete and report back to the county.
