V. <u>CHANCELLOR'S UPDATES</u>

Chancellor Salgado began by thanking Chair Massey for his 6 years of service. We saw some of CCC's progress on display at today's committee meeting with the presentation of the FY23 audit.

We have successfully turned around City Colleges financial health, achieving positive unrestricted assets for the first time in FY22 and continuing to grow those assets in FY23, and rebuilding our cash reserve.

We were recently rewarded with increase in our credit ratings by both Fitch and S&P rating agencies.

We recognize CFO Maribel Rodriguez and the finance team for their leadership and for being excellent partners to me in managing this turnaround.

MXC Medical Assistance Program Director, Christine Dzoga was appointed by the American Association of Medical Assistants to chair a team seeking to understand how the AAMA can better support Medical Assistant programs across the country.

The Kennedy King College Tech Launchpad was named one of 100 finalists for the 22nd annual Chicago Innovation Awards.

Harold Washington College President Daniel Lopez was named to the Hispanic Association of Colleges and Universities (HACU) Governing board.

Malcolm X College President David Sanders was named a Chicago Titan 100, which recognizes executives contributing to the growth of their organization.

IX. <u>COMMITTEE REPORT</u>

Trustee Williams presented the Finance and Administrative Services Committee Report.

The committee met today with RSM and the City Colleges of Chicago's auditor, presenting their findings of the audit process for CCC's fiscal year 2023 Financial results. RSM partner Kelly Kirkman discussed the audit engagement process and scope, presented those communications required to be discussed with the governance body, discussed internal audit controls and single audit findings.

Chief Financial Officer Maribel Rodriguez presented a summary of the fiscal year 2023 actual operating results relative to budget and presented the cash and net asset positions. CFO Rodriguez also provided an update on expected fiscal year 2024 results relative to the budget as discussed in the committee meeting and as highlighted by Chancellor Salgado.

Chair Williams stated that the presentations and discussions provided good news all around. The audit is presented on time and clean with no material weaknesses or deficiencies.

RSM confirms that the audit process went smoothly with strong cooperation and collaboration from the finance team.

Financial results came in strongly positive relative to budget. CCC was able to put funds into Reserve. We improved our net asset position and continue to maintain a strong cash balance. Our credit rating has improved, and our financial aid compliance reviews resulted in no requirements to return Title IV funding.

The committee joins the Chancellor in thanking and congratulating CFO Rodriguez, her team, the presidents of the colleges, and the financial leadership at the seven colleges for their hard work in getting the audit completed and in achieving such strong results.

The committee also reviewed the minutes, resolutions, personnel items, resource development report, agreements, purchases, and legal invoices included on today's Finance and Administrative Services agenda excluding Resolution 1.00, the Appreciation of Walter E Massey to be voted on separately as part of the consent agenda to this December 7th, 2023 regular board meeting.
