**INTERGOVERNMENTAL AGREEMENT WITH THE ILLINOIS DEPARTMENT OF EMPLOYMENT
SECURITY FOR DATA MATCHING TO MEASURE STUDENT EMPLOYMENT OUTCOMES
THE OFFICE OF ACADEMIC AND STUDENT AFFAIRS
DISTRICT WIDE**

WHEREAS, the Intergovernmental Cooperation Act, 5 ILCS 220 et seq., as amended, authorizes public agencies to enter into agreements and contracts to perform any governmental service, activity, or undertaking authorized by law upon approval of their respective governing bodies; and

WHEREAS, the Illinois Department of Employment Security (IDES) is the code department of the Illinois state government that administers state unemployment benefits, runs the employment service and Illinois Job Bank, and publishes labor market information; and

WHEREAS, **IDES** is able to establish data sharing, consistent with federal regulations pertaining to recipients of unemployment (UI) information (20 CFR 603); the confidentiality requirements of the Illinois Unemployment Insurance Act (820 ILCS 405/1900); the Illinois Personal Information Protection Act (815 ILCS 530); the Illinois Identity Protection Act (5 ILCS 179); and the Illinois Data Processing Confidentiality Act (30 ILCS 585); and

WHEREAS, City Colleges of Chicago (“District”) seeks to verify that programs remain competitive in the job market and graduates are earning wages consistent with industry standards; and

WHEREAS, the District seeks to measure students’ and graduates’ economic mobility; and

WHEREAS, the District has an executed data sharing agreement with IDES that was effective October 1, 2023, and will terminate on September 30, 2025 with an option to renew for an additional 1-year term for these services that were previously available to the district at no cost

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois, authorizes the Chair, upon final approval of the General Counsel as to the legal form of such an agreement, to terminate the existing agreement, and execute and Intergovernmental Agreement with the Illinois Department of Employment Security to provide wage records for students, for the period from February 1, 2024 through September 30, 2025 at a total cost not to exceed \$35,000, with an option to renew for an additional 1 year term.
