TO SET TUITION FOR BOARD PROGRAMS
THE OFFICE OF FINANCE
DISTRICT WIDE

WHEREAS, the Illinois Public Community College Act (110 ILCS 805/3-45) authorizes a Community College Board to require tuition; and

WHEREAS, Section 4.3 of the Board Bylaws of City Colleges of Chicago provides for the adoption of policies and states that:

“The Board may adopt, from time to time, policy statements, guidelines, procedures, regulations, collective bargaining agreements, codes of conduct, or similar documents issued for the governance of the Board, the District and the Colleges.”

WHEREAS, the Board of Trustees has previously approved, adopted and now seeks to amend such tuition and fees; and

WHEREAS, a tuition increase of \$7 per credit hour for in-district tuition for fiscal year 2025 will now be implemented, and those tuition rates will be posted publicly on the tuition page of the City Colleges of Chicago Web site; and

WHEREAS, tuition for credit classes will be charged per credit hour per the chart below:

WHEREAS, specialized tuition for courses* in certain healthcare programs (see attached list) will be charged per credit hour per the chart below, reflecting a comparable increase for fiscal year 2025:

WHEREAS, the basic certificates in construction offered at Dawson Technical Institute will now be offered at the standard per credit hour tuition, rather than a flat rate, to bring tuition for these programs in line with program tuition at neighboring community colleges; and

WHEREAS, programs where tuition is laid out contractually within defined partnerships shall continue to be charged at their current rates negotiated rates:

WHEREAS, students who enroll by June 30, 2024 will receive an early-registration discount in which they will register at existing tuition rates;

NOW, THEREFORE BE IT RESOLVED, that the aforementioned revisions to tuition shall be adopted by the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois with an effective date of April 1, 2024 for the Fall 2024 term.
